WHO ARE WE

The Commonwealth Ports Authority (CPA) is an autonomous government agency that was established by Commonwealth of the Northern Mariana Islands (CNMI) Public Law 2- 48 on October 08, 1981. CPA is responsible for all airports and seaports on the islands of Saipan, Tinian and Rota. The island of Pagan has an airstrip but it is currently unavailable for air travel.

CPA has seven Board of Directors who are appointed by the CNMI Governor and confirmed by the Senate.

CNMI's source of revenue relies heavily on tourism. Over 90% of goods entering the islands are passed through its ports. CPA continues to work hard to improve its ports.

OUR FINANCES

The Commonwealth Ports Authority (CPA) generates revenues from port users to fund operating expense, capital projects, and debt service requirements. The CPA also receives federal grants from the Federal Aviation Administration (FAA), Department of Homeland Security (DHS), and the Department of Interior (DOI) to fund improvements throughout the ports.



CPA manages its funds separately for the airports and seaports. CPA's enabling legislation (CNMI Public Law 2-48), federal grant assurances and CPA's Bond Indentures do not allow the comingling of funds between the airports and seaports. CPA operates on a fiscal year (FY) from October 1 through September 30.

OPERATING REVENUES

Operating revenues include revenues earned for operational activities and do not include federal grant funding

AIRPORT - FY 2022 operating revenues for the airports increased by 262% as compared to FY 2021. This significant increase was due to the return to operations of limited international flights and the implementation of a new rate methodology. Aviation fees include landing fees and terminal rental rate charges. Other revenues include parking fees, permit fees and citation and training fees.

SEAPORT - FY 2022 operating revenues for the seaports remained steady with a 5% increase as compare to FY 2021. The increase was due to a slight increase in inbound revenue tonnage. Harbor fees include wharfage fees, docking fees, special services, berthing fees and port entry fees. Other revenues include permit fees, citations and security service fees.

OPERATING EXPENSES

AIRPORT & SEAPORT - Other expenses include fuel, travel, communications, promotional expenses and penalties and interest expenses.


AIRPORT - Overall FY 2022 operating expenses for the airports increased by 27% as compared to FY 2021. This increase is mainly due to the increase in utility costs and restoration of regular hours for employees due to the receipt of federal grant funds for operations.

SEAPORT - Overall operating expenses for the seaports increased by 37% as compared to FY 2021. This increase is due to the increase in utility costs and the restoration of regular hours for employees.

OUTLOOK





- OLDCC Grant through CBMA—Owner Agent Engineer Program-contractual services for Project Management Support, CIP Technical Oversight, Airport Supplemental Baseline Condition Assessment, Seaport In-Water Condition Assessment and Ferry Terminal Planning—\$1,500,000.00
- CPA has applied for FAA ATP grants for the Rota Airport Roof Canopy Replacement Project. If approved, CPA anticipates funding by 2024. Project includes replacement of entire canopy and repairs to existing concrete roof.
- Thee U.S. Department of Transportation Rebuilding America infrastructure with Sustainability and Equality (RASE) grant program awarded the Commonwealth Ports Authority \$3,3135.000.00 for the Saipan Harbor Navigation Improvements. This planning project will study potential navigational improvements in the Saipan Harbor, for two potential future projects: 1) extend Charlie-1 Dock, and 2) associated dredging to allow larger vessels to dock at the port, including cruise ships and updated liquid bulk vessels.





CHALLENGES

- ⇒ COVID 19: The pandemic continues to affect travel to the CNMI which makes it difficult to forecast future budget.
- ⇒ Loss of Airlines / Flights: Since the inception of COVID-19, the majority of airlines ceased operations and have pulled out of the CNMI. There are currently four airlines that have resumed travel to Saipan
- ⇒ Financial Constraints: CPA employees were the first government employees to have their hours reduced and the last to be restored. CPA continues to implement cost-cutting measures on operational cost.
- Personnel Shortage: All departments were faced with personnel shortage due to the tight cost-cutting measures. Only critical positions were approved for replacements.
- ⇒ Trainings on Hold: Departments' personnel job enhancement trainings were put on hold due to lack of funding since the pandemic.
- Rota Quarry: Due to limited quarry operations, construction projects

have been delayed. Contractors import quarry from Saipan or Guam driving the cost of construction up

WHAT'S NEXT

- Promote Additional Airlines: CPA will continue to promote for additional airlines for international and inter-island travel and improve the airport facilities for better service.
- Airport and Seaport Improvements: CPA will continue to make improvements to its airports and seaports on Saipan, Tinian and Rota to ensure that passengers and cargoes are processed effectively and efficiently.

TRAINING AND EXERCISES

- ♦ FAR Part 139 Live Fire Recertification: Annual mandatory requirement for all airport fire fighters under FAR Part 139 to participate in a live fire recertification burn. Total number recertified only accounts for CPA's airport fire fighters from Saipan, Tinian and Rota for a total of 27.
- Firearms Semi/Annual Recertification: Mandatory Annual requirement for all Ports Police officers.
- Canine Unit: Under TSA National Explosive Detection Canine Team Program re- quires all Canine Teams to undergo an Annual Evaluation Exam
- Triennial Exercise: Mandatory every three years, every airport needs to conduct the Triennial Exercise to test its Airport Emergency Plan in order to meet FAR Part 139 requirements
